5. Learning outcomes

The parties have agreed that the following learning outcomes should be achieved during the learning mobility:

1. Outcome 1: Raising awareness regarding the environment	
Relevant subject, skill or competence:	Drama, singing, music, crafting, writing, discussion
Description:	Participants will engage in a number of performing arts activities, each aimed at raising awareness of the environmental issues we face as a planet, through these artistic mediums.

1. Outcome 2: Learning new ways to promote environmental	
awareness with students	
Relevant subject, skill or competence:	Drama, singing, music, crafting, writing, discussion
Description:	Participants will directly experience and thereby learn many performance-based activities, games and exercises around the theme of environmental awareness, which they in turn will be able to use in their own classroom practice.

Outcome 3: Learning new CLIL approaches	
Relevant subject, skill or competence:	Drama, singing, music, crafting, writing, discussion
Description:	By learning through the performing arts in the English language, teachers who are keen on developing their CLIL skill-set will have the opportunity to widen their working palette in that sense through all the activities they will be engaged in.

Outcome 4: Developing communication skills



Relevant subject, skill or competence:	Drama, singing
Description:	The games and exercises are also meant to develop participants' awareness of themselves as communicators, and to help them in the process of becoming more effective, expressive and intentional in their communication.

Outcome 5: Developing a growth mindset in relation to one's teaching practice	
Relevant subject, skill or competence:	Drama, music
Description:	Especially when it comes to the improvisational games and exercises we will be doing, participants will have many opportunities to develop a growth mindset, which they in turn can incorporate in their own classroom.

6. Learning programme and tasks

To achieve the agreed learning outcomes, the participant will complete the following activities and tasks during their mobility activity.

Activity / task 1: Drama games and exercise	
	Fun games and exercises aimed at helping participants engage with one another in a new way, as well as to approach the theme of environmental awareness creatively.

Activity / task 2: Music	
	Songs and song-writing will play an important part in the week's activities, as a means to engage creatively and collaboratively with the environmental themes at hand.

Activity / task 3: Instrument-making	
Description:	The theme of recycling being so central to environmental awareness, will be explored through the making of one's own musical instruments through recycled materials.

Activity / task 4: Script-writing	
Description:	Writing a short script on the theme (and sub-themes) of environmental awareness will play an important part of the week's process, allowing thoughts and feelings on the theme to materialize in the guided creation of a script.



Activity / task 5: Improvisation	
Description:	Improvisation exercises will feature a lot, in order to help participants develop a 'less is more' and growth mindset so crucial to the question of environmental awareness.

7.4 Mentoring and monitoring arrangements

As a minimum, the monitoring and mentoring arrangements will include the following activities:

8. Evaluation of learning outcomes

After the mobility activity, the participant's learning outcomes will be assessed in the following way:

Evaluation format:

Evaluation will take the form of group and individual self-evaluation conversations at the end of the course with the course mentor, as well as a short written evaluation sent to each participant on behalf of the course mentor. This will not include grades.

Evaluation criteria:

Evaluation will be assessed, based on the effort demonstrated by the participant in the following areas:

- 1. Attitude
- 2. Creativity
- 3. Team-work
- 4. Understanding of the approaches and the themes

Evaluation procedures:

Evaluation will take place through the mentor's observations throughout the week. The assessment will be qualitative, aiming at the development of skills on environmental protection (training of attitudes and skills).

9. Recognition of learning outcomes

After the mobility activity, the participant's learning outcomes will be assessed in the following way:



Recognition conditions:

Occasional email correspondence between the mentor and individual participants, where they report how they are using the activities and approaches they have learnt, in their classroom practice.

Recognition procedures:

The learners will be responsible for communicating their experiences to the mentor, who in turn will acknowledge these reports with feedback.

Recognition documentation:

The mentor will issue an Essere Theatre certificate at the end of the course, including the duration of the course. Essere Theatre is part of The European Association of Training Providers. Participants will be given a course participation certificate stating their participation, with the course program and also the Europass Mobility.
